PAPER 4 – RE-ELECTION/ELECTION OF DIRECTORS

As part of the normal process at the AFCW PLC AGM, we present resolutions to seek shareholders' authorisation to re-elect and/or elect directors of the company as appropriate.

The Board seeks authorisation from members to cast the Trust's votes at AFCW PLC's Annual General Meeting in favour of approving the reappointment of Graeme Price and James Macdonald as directors of AFCW PLC.

In addition to these appointments, after three years in post as a director of AFCW PLC, Iain McNay is now standing for re-election as a director at the AFCW PLC AGM. As part of the governance changes made in December 2022, the AFCW PLC Articles were amended at the December 2022 AGM (in particular clause 84.3) to set out the structure of the Board to be as follows:

- a) the Directors shall be appointed on terms agreed and approved by the Society Board;
- b) the Company Board will be made up as follows: an AFC Wimbledon Chair as appointed from time to time by the Society Board, 2 directors representing minority shareholders, 3 directors who are Society Board members and up to 6 non-executive directors appointed for specific knowledge and experience. Any subsidiary of the Company shall also have the same Board structure, except that for AFC Wimbledon Ladies FC Limited there must be one member of the Society Board and one member of the AFCW PLC Board represented on its Board.

It was also agreed that there would be further changes brought to amend the rules in 2024 such that the minority shareholders of AFCW PLC should themselves decide which two people should represent them on the Board. In the interim, the Dons Trust Board have agreed therefore that they will not cast the Dons Trust vote on any resolution to appoint a minority shareholder Board representative and that for this 2023 AFCW PLC AGM, the minority shareholders alone should cast their votes.

Resolution 6 – background to Graeme Price

I was elected to the Dons Trust Board in December 2022 and, on the resignation of Kris Steward from the DTB and PLC board, was the unanimous choice to replace Kris as a DTB representative on the PLC board. I believe my experience of being Chief Operating Officer for a £17m turnover Multi Academy Trust allows me to use my experience to help the club deliver success within its means. Working in education provides me with the experience of making tight budgets work but primarily my role is to represent the Dons Trust Board on the operational side of the club and ensure that decisions are taken with the best interests of the owners of the club.
